Metallic coatings:

Galfan (Zn – Al), Aluzinc® (Al – Zn), ALUSI® (Al – Si), ALUPUR® (Al), Magnelis® (Zn – Al – Mg), Electrogalvanized (Zn) steels are in accordance with the European Directive on electric and electronic equipments. Those products are produced without intentional additions of lead, cadmium, mercury and chromium VI.

Hot dip galvanized (Zinc): if specifically required in a customer purchase order, ArcelorMittal will deliver hot dip galvanized steel without addition of lead.

Finishing treatments:

Phosphatation (P), E-passivation®, Easyfilm® E, HPE, HFE, COE are in accordance with the European Directive on electric and electronic equipments.

Prepainted and Composite Steels:

Estetic® Bright, Estetic® Cold, Estetic® Hot Estetic® Wet, Estetic® High Tech, Estetic® Lighting, Estetic® Conductive, Estetic® Clean and Estetic® Ambient Platinum are always delivered in accordance with the European Directive on electric and electronic equipments.

Other prepainted steels can also be delivered in accordance with the European Directive on electric and electronic equipments, if agreed at the time of enquiry and order.
